Similarly this catalogue does not address the training required to undertake specific experiments or activities - how these are undertaken should be based on the risk assessment and as appropriate method statement for the activity planned with instruction and as appropriate supervision from your line manager.

Please note that SHE Group optimises the delivery of training courses across STFC sites to deliver in-house courses which are significantly cheaper than off site equivalents. To do this we hold course waiting lists which consequently means that individuals may need to wait for course numbers to reach a cost effective minimum before courses are planned. If you are commencing work with a new hazard and require training more urgently please contact SHE Group and we will put you in contact with a public provider.
